MRSC Rosters publishes five different regionally focused legal notices representing the five main regions of Washington State, and one statewide legal notice. The posting for those agencies whom utilize the Small Works and Consultant Roster will be annual, which means those agencies who join or renew by May 1st each year will be published in the June legal notice, while those agencies who join or renew by December 1st each year will be published in the January legal notice. The posting for those agencies whom utilize the Vendor Roster in addition to the Small Works and Consultant Roster will be published biannually.
